The undersigned, acting as Incorporator of a corporation under the FLORIDA GENERAL CORPORATION ACT, adopt the following ARTICLES OF INCORPORATION for such corporation:

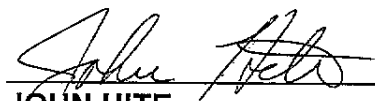

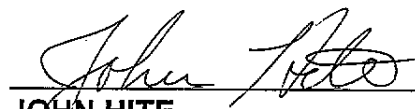
