**ARTICLE 1 - CORPORATE NAME**

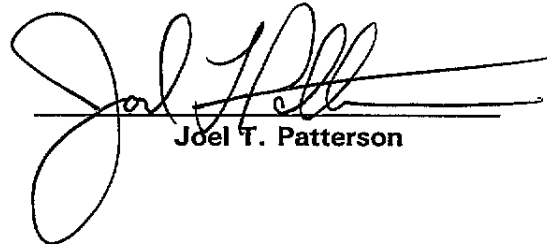

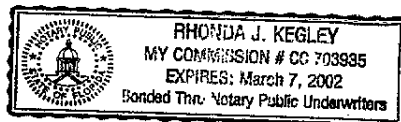

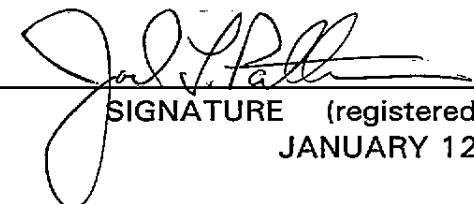
