

The undersigned, a natural person competent to contract, hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

**ARTICLE I : CORPORATE NAME**

The name of this Corporation shall be: JORDAN ASSOCIATES, INC., and its principal office shall be located at 150 E. Palmetto Park Road, Suite 514, Boca Raton, Florida 33432.

**ARTICLE II: NATURE OF CORPORATE BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation shall be to engage in any and all lawful business permitted under the laws of the United States and the State of Florida.

**ARTICLE III: CAPITAL STOCK**

Pursuant

to Florida Statute 607.0850(9), no court order indemnification shall, under any circumstances, be permitted.


**ARTICLE X: AFFILIATED TRANSACTIONS**

This Corporation expressly elects not to be governed by Florida Statute 607.0901, as amended from time to time, relating to affiliated transactions.

**ARTICLE XI: CONTROL SHARE ACQUISITIONS**

This corporation expressly elects not to be governed by Florida Statute 607.0902, as amended from time to time, relating to control share acquisitions.
