**ARTICLE I - NAME**

The name of this Corporation is Victor Hall Transport, Inc.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**



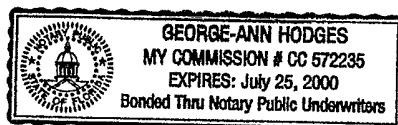


