ARTICLE ONE

The name of the proposed corporation is **A.D. OF SOUTH FLORIDA, INC.** The principal address of the corporation is: 656 E. Drive N.W. 36th Street, Miami Springs, Florida 33166.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act. The corporation, in furtherance of its corporate purposes, shall have all the powers enumerated under the Florida Corporation Act, subject to any limitations provided in the Act, or any other statute of the State of Florida.

The aggregate number of shares which the corporation shall have the authority to issue is one thousand (1000), all of which are to be common stock without nominal or par value.

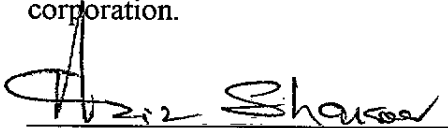
ARTICLE FIVE

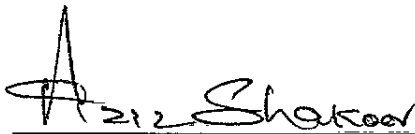
#### ARTICLE EIGHT
