ARTICLE I - NAME

THE NAME OF THIS CORPORATION UNDER CODE SECTION 621 OF FLORIDA STATUTES IS SUZANNE M. WILLIAMS P.A.

ARTICLE II - PURPOSE

THIS ORGANIZATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING BUSINESS AS A LICENSE REAL ESTATE PERSON.

ARTICLE III - DURATION

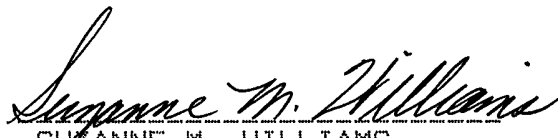
ARTICLE IX - INDEMNIFICATION

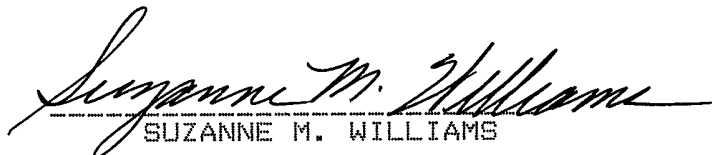

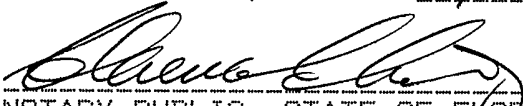
