ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
SUMMIT CAPITAL PARTNERS, INC.

Pursuant to the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is QUANTUM CAPITAL PARTNERS, INC.
2. The following amendment of the Articles of Incorporation was adopted by the Board of Directors of the corporation on March 26, 1999, in the manner prescribed by the Florida General Corporation Act. The amendment was approved by the majority of the shareholders entitled to vote.
