# ARTICLES OF INCORPORATION OF KB CONSULTING CONCEPTS, INC.

These Articles of Incorporation are executed and acknowledged by the undersigned incorporator for the purpose of organizing a corporation for profit under the Florida General Corporation Act and sets forth that:

#### ARTICLE I Name

The name of the corporation is KB Consulting Concepts, Inc. The mailing address of KB Consulting Concepts, Inc. is 675 Saranac Drive, Winter Springs, Florida 32708

# ARTICLE II Purpose

The general purpose or purposes for which this corporation is organized is to engage in the transaction of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

### ARTICLE III Capital

The aggregate number of shares which this corporation has authority to issue is 10,000 shares of capital stock of the par value of \$1.00 each, all of which shall have the same rights and privileges.

Meetings of the shareholders and directors of the corporation may be held at places within or without the state of Florida and the place or places for the holding of such meetings may be specified in the By-Laws or in the notice of the meeting.

### ARTICLE V Board of Directors

The exact number of directors shall be fixed, and may be increased or decreased from time to time, in the manner provided for in the By-Laws. No such decrease shall have the effect of shortening the term of any incumbent director. The corporation shall indemnify every person who is serving or has served as a director, officer, employee, or agent of the corporation, or at the request of any other corporation, partnership, joint venture, trust, or other enterprise in the manner and to the full extent permitted by the Florida General Corporation Act, subject to the limitations and conditions of such indemnification set forth therein, which indemnification shall not affect other rights to which such person may be entitled.

# ARTICLE IX Preemptive Rights

Shareholders of the Corporation shall not have preemptive rights.
