ARTICLES OF INCORPORATION

The undersigned, **FRED McINTURFF**, does hereby execute and acknowledge the following Articles of Incorporation:

1. The name of the corporation is **REAL ESTATE HOME REPAIR, INC.**

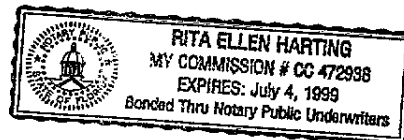


