## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

## FERRERO, BUSCHEL, CARTER & SCHWARTZREICH CHARTERED

The following provisions of the Articles of Incorporation of Ferrero, Buschel, Carter & Schwartzreich Chartered, a Florida corporation (the "Corporation"), filed with the Department of State on February 16, 1998, document number P98000015758, be and they are hereby, amended as shown below:

Article I of the Articles of Incorporation of this Corporation is hereby deleted in its entirety and replaced with the following:

## ARTICLE I NAME

The name of the corporation shall be: Ferrero, Buschel, Carter, Schwartzreig Yates, P.A.

Article III of the Articles of Incorporation of this Corporation is hereby deleted in its entire and replaced with the following:

## ARTICLE III SHARES

The authorized capital stock of this corporation shall consist of five (5) shares of common stock with a par value of One Dollar (\$1.00) per share.

The foregoing amendment was adopted by a Joint Consent Action of all of the Shareholders and the Board of Directors of this Corporation, dated the 1st day of November, 1999. The number of votes cast in favor of the foregoing amendment was sufficient for approval.
