**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION OF  
FERRERO, BUSCHEL, CARTER, SCHWARTZREICH & YATES, P.A.**

The following provisions of the Articles of Incorporation of Ferrero, Buschel, Carter, Schwartzreich & Yates, P.A., a Florida corporation (the "Corporation"), filed with the Department of State on February 16, 1998, under document number P98000015758, be and they are hereby, amended as shown below:

1. Article I of the Articles of Incorporation of this Corporation is hereby deleted in its entirety and replaced with the following:
