ARTICLES OF INCORPORATION

OF

BMS of NORTH BAY VILLAGE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is BMS of NORTH BAY VILLAGE, INC.

DURATION

The duration of the corporation is perpetual.
