The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation under Professional Service Corporation Act, (Chapter 621) of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of the corporation is Jordan H. Jordan, P.A.

ARTICLE II

NATURE OF BUSINESS

The purposes for which this corporation are formed are :

- a) To engage in every phase and aspect of business or rendering services to the public that an attorney at law, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through individuals authorized by the laws of the State of Florida to render such professional services.
- b) To transact any lawful business for which corporations may be incorporated under the Florida Business Corporations Act.

ARTICLE III

CAPITOL STOCK

The maximum number of shares of stock this corporation is authorized to issue at any one time is One Thousand (1,000) shares of common stock, each share having the par value of (\$.10) per share. The consideration paid for each share shall be fixed by the Board of Directors from time to time.

EFFECTIVE DATE

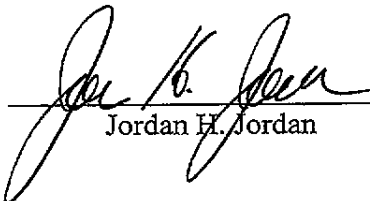
The initial date of incorporation shall be effective upon approval by the Secretary of the State of Florida.

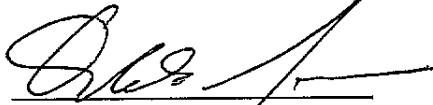


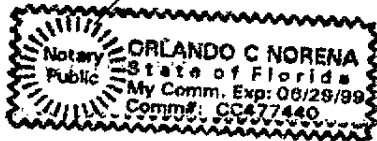
