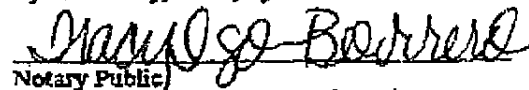

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF TRS ACQUISITION CORP.  
(CHANGING THE NAME OF THE CORPORATION TO:

Pursuant to the provisions of §§ 607.1003 and 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:
