ARTICLES OF INCORPORATION

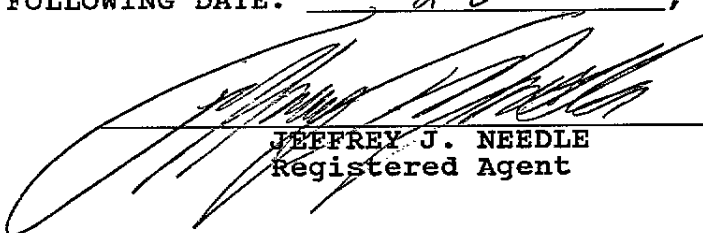

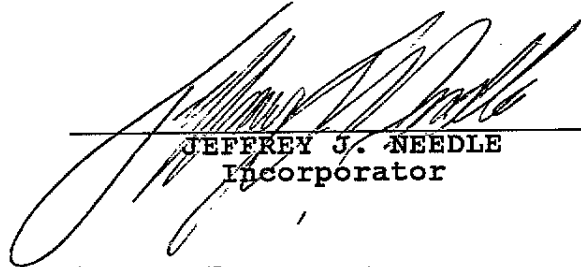

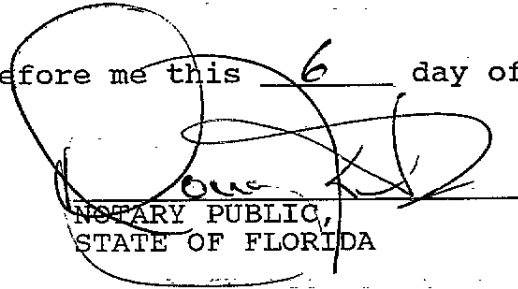
