ARTICLES OF INCORPORATION

The undersigned does hereby act as the incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act and the Florida Business Corporation Act.

ARTICLE ONE

The name of the Corporation shall be Mark N. Hashim, P.A.

ARTICLE TWO

The principal place of business and mailing address of the Corporation is 3435 Black Willow Trail, Deland, Florida 32724.

ARTICLE THREE

The number of shares that the Corporation is authorized to issue is Ten Thousand (10,000) shares, all of which shall have a par value of Ten Cents (\$.10) per share. All shares of the Corporation shall be of the same class and shall be common shares.
