**ARTICLES OF AMENDMENT

1. The following provisions of the Article of Incorporation of **DIVERSIFIED SELECT MORTGAGE SERVICES OF TAMPA, INC.** a Florida corporation, filed with the Florida Secretary of State on FEBRUARY 18, 1998, document number 98-000016066, be and hereby are amended in the following manner:

A. Article I is hereby amended to read as follows:

ARTICLE I

The name of the corporation is ***SELECT MORTGAGE SERVICES OF TAMPA, INC.***
