ARTICLES OF INCORPORATION OF

ENDOCRIN & DIABETES TREATMENT ASSOCIATES, INC.

The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the Corporation is ENDOCRIN & DIABETES TREATMENT ASSOCIATES, INC. (the "Corporation").
