Pursuant to Chapter 607, the undersigned Officers having organized this 1st day of January, 1998, Immediate Contract Services, Inc., to hereby apply for its Charter for the purpose of conducting any and all business which corporation may be legally authorized to conduct business under the laws of the State of Florida. **ARTICLE VI**

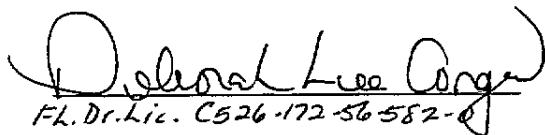

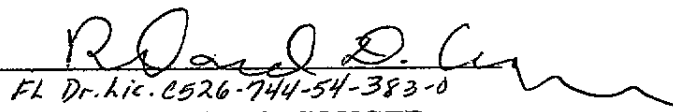
**ARTICLE VI**

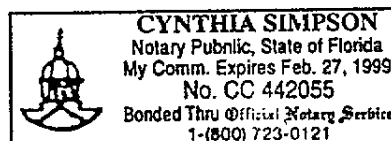

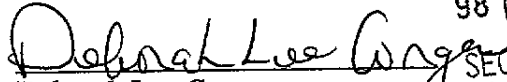
