The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is SieMac Services, Inc.

ARTICLE II

The duration of this corporation is perpetual.

ARTICLE III

The general purposes for which this corporation is organized are:

1. To engage in the transportation of commercial U-Haul trucks between various regional dealer locations.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

The aggregate number of shares which the corporation is authorized to issue is ten thousand (10,000). Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00)

per share.

The principal street address of the registered office of the corporation is 1418 E. Jackson Street, Pensacola, Florida and the name of its registered agent at such address is Ken McAskill. The principal address and the registered office address are the same.

#### ARTICLE VI

The number of directors constituting the initial Board of Directors of the corporation are two (2). The names and addresses of the persons who are to serve as members of the initial Board of Directors are:

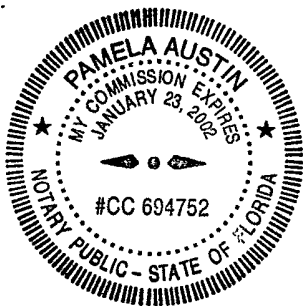

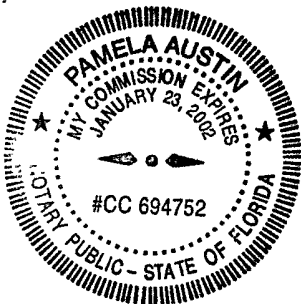
