XIII

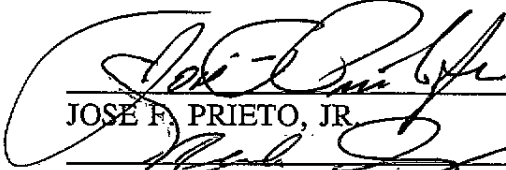

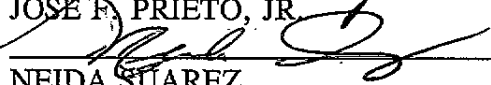

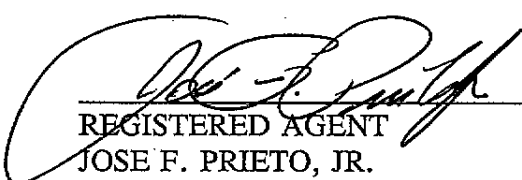
