CERTIFICATE OF INCORPORATION OF

Spectrum MAGAZINE INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be
SPECTRUM MAGAZINE INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 337 Peregrine Court, Jacksonville, FL 32225.

ARTICLE III PURPOSE:

The purpose of the corporation is to engage in copying, printing, graphics, direct mail advertising and typesetting of all kinds. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Florida.

The corporation is authorized to issue only one class of stock. The total number of shares is one share and without par value. The corporation elects to have preemptive rights.

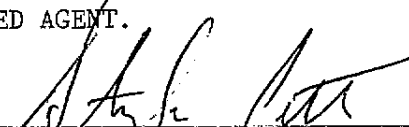

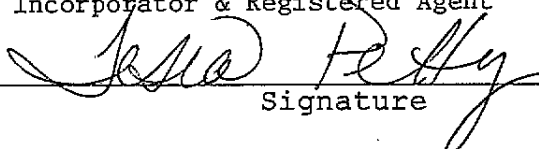
