

ARTICLE I
NAME

The name of this Corporation is **ALL COMMODITIES CORP.**

ARTICLE II
DURATION

This Corporation shall have perpetual existence.



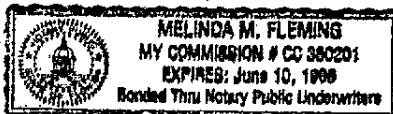
