I, the undersigned Incorporator, do hereby form a Corporation under the laws of the State of Florida.

The principal office of this Corporation shall be located at Suite 203, 900 Sixth Avenue, So., Naples, FL 33940.

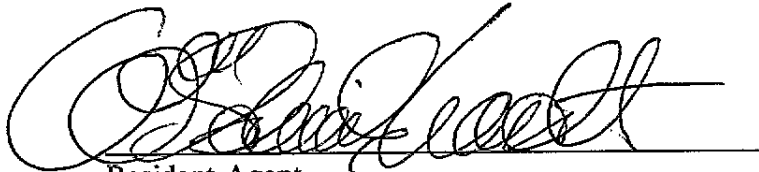
