Accordingly, I am requesting that the late fee of \$400 be waived and that the enclosed check in the amount of \$150 be accepted along with the enclosed UBR.

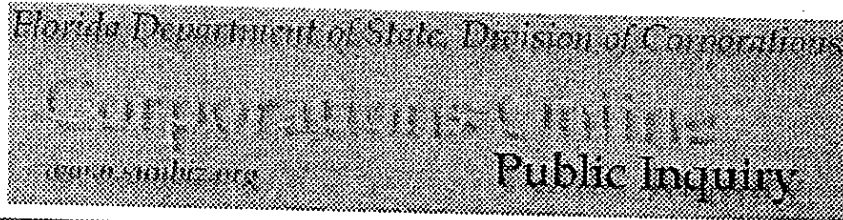
