#### ARTICLE I

# <u>NAM</u>E

The name of the Corporation is Precision Frame & Trim, Inc. principal office address and the mailing address of said Corporation is 2806 Elisa Drive West Jacksonville, Florida 32216.

#### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.


