The undersigned subscriber to these Articles of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. - NAME

The name of the corporation is Crest Walk In Clinics, Inc.

This corporation is organized for the purpose transacting any and all lawful business.

ARTICLE III. - DURATION





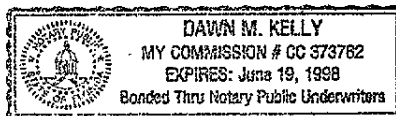
