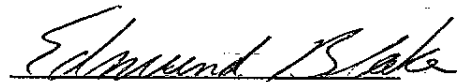

**ARTICLE ONE**

The name of the corporation is **A 1 Transport Services, Inc.** The principal address of the corporation is: 1802 N. University Drive, #292, Plantation, Florida 33322.

**ARTICLE FOUR**

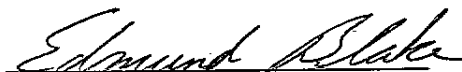
The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**
