THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, each a natural person component to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is:

This corporation may engage in the transaction of any and all lawful business for which corporation may be incorporated under Florida law.

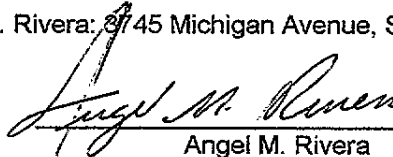

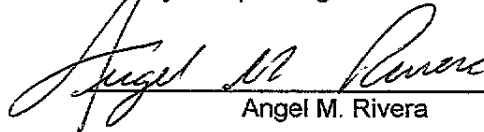
