# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

### ARTICLE · ONE

## NAME

The name of the corporation is VICTORIA INTERNATIONAL GROUP, INC.
