
ARTICLE IX - Indemnification:



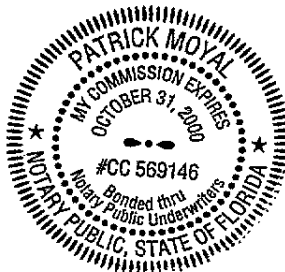
