ARTICLE I - NAME

The name of this corporation is: **AAAAA 5 STARS, INC.** with the principal place of business located at: **245 SE 1ST STREET STE 332, MIAMI, FL. 33131.**

ARTICLE II - PURPOSE

This corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK


