ARTICLES OF INCORPORATION

OF

C. ADAMS ENTERPRISES I, INC.

The undersigned incorporator(s), being an individual duly licensed to render fabrication and welding services, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.
