



The undersigned, acting as incorporators of a corporation under the Florida Generals Corporation Act, adopt the following Articles of Incorporation for such corporation:

- The name of the corporation is HAIR BY JOSEPH CARULLI, INC. 1.
- The address of the corporation is 830 101st Avenue North, Naples, Florida 34108 2.
- 3. The period of its duration is perpetual.
- The purpose or purposes for which the corporation is organized are to engage in any activity 4. or business permitted under the laws of the United States and the State of Florida.
- The corporation shall have authority to issue seventy-five hundred shares, all of one class, one 5. dollar par value.
- The address of its initial registered office is Gulf Coast National Bank, 3838 Tamiami Trail 6. North, Suite 416, Naples, Florida and the name of its initial registered agent at said address is Christian B. Felden.
- The initial Board of Directors shall consist of one (1) members, who need not be residents of 7. the State of Florida or a shareholder of the corporation.
- The names and addresses of the persons who shall serve as directors until the first annual 8. meeting of shareholders, or until their successors shall have been elected and qualified, are as follows:

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
