

# ARTICLES OF INCORPORATION OF

### PROMO ARGENTINA CORP.

We, the undersigned, all of whom are of legal age, do hereby associate ourselves for the purpose of becoming a corporation under the class of the State of Florida, authorizing the formation of corporation.

#### ARTICLE I

### CORPORATE NAME

The name of this Corporation shall be: PROMO ARGENTINA CORP.

#### ARTICLE II

#### GENERAL NATURE OF BUSINESS
