

ARTICLE I - CORPORATE NAME

The name of this corporation is THE LIGHTING LEARNING CENTER, INC., whose principal office and mailing address is 1126 Homer Street N.W., Palm Bay, Florida 32907.

ARTICLE II - NATURE OF BUSINESS AND POWERS
