Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Lucayan Purchasing, Inc. (the "Corporation").
2. In order to change the name of the Corporation, Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

ARTICLE I

NAME

The Name of this corporation is Harbour Plaza Purchasing Inc.

3. The foregoing Amendment to the Articles of Incorporation was approved by a resolution of the sole shareholder of the Corporation dated 21st January, 1999 in accordance with Sections 607.1003 and 607.1006 of the Act. The number of votes cast by the sole shareholder was sufficient for the approval of the foregoing Amendment to the Articles of Incorporation.

4. The Amendment to the Articles of Incorporation effecting the name change shall be effective on the date of filing of these Articles of Amendment with the Florida Secretary of State.
