CORPORATE NAME

The name of this corporation is:

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

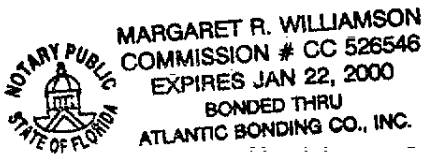
