



The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the law of the State of Florida.

ARTICLE 1 - CORPORATE NAME

This corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in any activities or business permitted under the law of the United States and the State of Florida.

The corporation is authorized to issue ONE THOUSAND shares (1,000) of One dollar (1.00\$) par value Common Stock, which shall be designated ``Common shares``.
