AMALGAMATED LAND COMPANY II**


Pursuant to Sections 607.1001, 607.1004, 607.1006, and 607.1009, Florida Business Corporation Act, the following provisions of the Articles of Incorporation of Amalgamated Land Company II, a Florida corporation, filed in Tallahassee on February 24, 1998, be and they hereby are amended in the following particulars:

Article 1, Section 1.1 ("Name") be and it hereby is amended to read as follows:
