The undersigned subscriber of the Articles of Incorporation, a natural person competent to contract, hereby associates himself together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Jensen Tire and Service Center, Inc.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United State and of this state.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, each share having the par value of five dollars (\$5.00).

Authorized capital stock may be paid for in cash, services or property at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.
