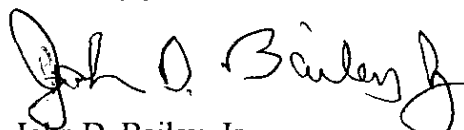
Dear Sir or Madam:

Enclosed please find the 2000 Uniform Business Report (UBR) for Edge & Maguire, Inc. The purpose of this letter is to request that the Division of Corporations waive the \$400 late fees which are due in connection with this filing.

In June of this year, the directors of the corporation became aware that the 2000 UBR was returned for lack of an Employer Identification Number (EIN). Apparently, on the 1999 UBR it was noted that an EIN had been applied for. After a review of our firm's files and numerous telephone conferences with the directors, we became aware that the previous Registered Agent never applied for an EIN. Once this was determined, the necessary paperwork was prepared and an EIN was applied for on July 17, 2000. The new EIN was provided to the corporation's accountant sometime in August, but due to inadvertence was not delivered to us until this week at which time we prepared the enclosed 2000 UBR.
