ARTICLES OF INCORPORATION OF

A BETTER DEAL, INC.

The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE 1. - NAME

The name of this corporation is: A BETTER DEAL, INC.

ARTICLE 11.- NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a)To engage in all aspects of contracting, such as, electrical, plumbing, carpentry, masonry & other related trades, to buy, sell, manage & rent real estate & to engage in any & all other functions, services and/or activities considered as necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
