ARTICLES OF INCORPORATION
OF
FAST TRACK OF GAINESVILLE, INC.

ARTICLE I - NAME

The name of this corporation is: FAST TRACK OF GAINESVILLE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE


ARTICLE IX - INDEMNIFICATION

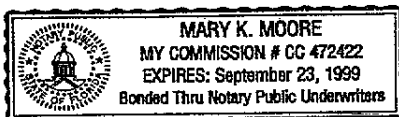




