

ARTICLES OF INCORPORATION



ARTICLE 1:

NAME

The name of this Corporation shall be: SOUTH WEST REHAB OF FLORIDA, INC.

ARTICLE II:

NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE III:

TERM OF EXISTENCE

This Corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida. The date on which Corporate existence shall begin, will be the date of filing of these Articles with the Secretary of State.

ARTICLE IV:

CAPITAL STOCK

This Corporation is authorized to issue shares of stock as follows:

Designation: The stock of this Corporation shall be known as Common Stock. 1.

Authorized: The maximum number of shares of Common Stock that this Corporation 2.

may issue is 1,000 SH.

Consideration: Shares of Common Stock may be issued in exchange for cash, real property, labor or services rendered, or in any combination of the foregoing. The 3. judgement of the Board of Directors shall be conclusive as to the value of any such consideration.

Each share of Common Stock shall be issued in exchange for Non-Assessability: consideration which is at least equal to the par value thereof, and shall be fully paid 4.

Par-Value: Each share of Common Stock shall have the par value of: One Dollar 5.

Voting Rights: Each share of Common Stock shall entitle the record holder thereof to one vote upon each proposal presented at meetings of the Stockholders of the 6. Corporation.

Dividends: Record holders of Common Stock are entitled to receive their pro-rata share of any dividends that may be declared by the Board of Directors out of assets legally 7.

available for such purposes.

Liquidation Rights: Holders of Common Stock are entitled, in the event of liquidation or dissolution of this Corporation, to receive their pro-rate share of any assets of this 8. Corporation remaining after payment of all corporate debts and obligations.

ARTICLE V:

DIRECTORS

This Corporation shall have - 1 - Director initially. The number of Directors may be increased or diminished from time to time by the By-Laws, but shall never be less than one. The names and addresses of the initial Director of this Corporation is:
