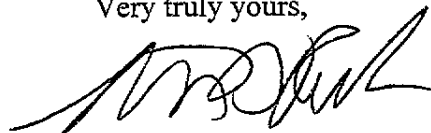

**ARTICLES OF INCORPORATION**

**ARTICLE I**

**CORPORATION NAME**

The name of the Corporation is SOUTHERN FOOD PRODUCTS, INC.

**ARTICLE II**

**PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE III**

**CAPITAL STOCK**

This Corporation is authorized to issue 500 shares of common stock.

The common stock of the Corporation shall have the following characteristics:

- (a) Par value shall be \$1.00 per share.
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of the outstanding stock.

#### **ARTICLE IV**

##### **TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

#### **ARTICLE V**

The street address of the initial registered office of this Corporation is 980 North Federal Highway, Suite 434, Boca Raton, Florida 33432. The name of the initial registered agent of this Corporation is Steven D. Rubin. The Board of Directors may, from time to time, change the street address of the Corporation as well as the location of its principal office. #### **ARTICLE VI**

##### **INITIAL BOARD OF DIRECTORS**

The Corporation shall have one (1) Director initially. The number of Directors may be increased from time to time by the by-laws, but shall never be less than one (1).
