ARTICLES OF INCORPORATION  
OF

WORLDWIDE MARINE SUPPLY, INC.

The undersigned, acting as incorporator of Worldwide Marine Supply, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:  
Worldwide Marine Supply, Inc.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon the filing of these articles and shall have perpetual existence.

ARTICLE III. PURPOSE

The general purpose or purpose for which the corporation is organized are as follows:

To transact any or all lawful business for which a corporation may be incorporated under the Florida General Corporation Act.

ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed or for which there are written promises to perform in the future for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT  
PRINCIPAL PLACE OF BUSINESS

The street address of the initial principal place of business and mailing address of the business is 9517 East Hillsborough Avenue; Tampa, Florida 33610 and registered office of the corporation is 11959 North Florida Avenue; Tampa, Florida 33612, and the name of the corporation's initial registered agent at that address is Antonio Duarte, III.

ARTICLE VI. INITIAL BOARD OF DIRECTORS

The corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The name and street address of the initial directors are:

ARTICLE VII. INCORPORATOR

The incorporator of the corporation assigns to this corporation his rights under Section 607.161, Florida Statutes, to constitute a corporation, and he assigns to those persons designated by the board of directors any rights he may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.


ARTICLE VIII. BYLAWS

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

ARTICLE IX. AMENDMENTS


The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation. These Articles may be amended prior to the issuance of shares of the corporation by the unanimous approval or consent of the board of directors. Thereafter, every amendment shall be approved by the board of directors, proposed by them to the shareholders, and approved at a shareholders' meeting by the holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.

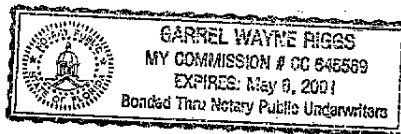


