ARTICLE I - NAME

The name of this Corporation is W.R.M. ENTERPRISE INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on February 17, 1998.

ARTICLE III - PURPOSE

price at which it is offered to others.






