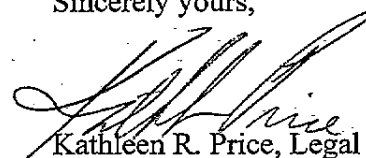

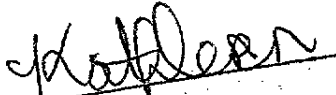

ARTICLES OF INCORPORATION
OF
MEDICAL DIAGNOSTIC IMAGING OF JUPITER, INC.

The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be MEDICAL DIAGNOSTIC IMAGING OF JUPITER, INC.

ARTICLE II

The principal office and mailing address of the Corporation is 2665 Hampton Bridge Road, Delray Beach, FL 33445.

ARTICLE III

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States of America or the State of Florida.

ARTICLE IV

The Corporation shall have the authority to issue Five Hundred (500) shares of common stock with a par value of One Dollar (\$1.00) per share.

ARTICLE V

The period of this Corporation's existence is perpetual.

ARTICLE VI

The street address of the initial Registered Office of this Corporation is 4400 PGA Blvd., Suite 800, Palm Beach Gardens, Florida 33410; and the initial Registered Agent of this Corporation at that address is Raymond W. Royce.

ARTICLE VII

ARTICLE X

The Corporation shall indemnify its Officers, Directors and Authorized Agents for all liabilities incurred directly, indirectly or incidentally to services performed for the Corporation, to the fullest extent permitted under Florida law existing now or hereafter enacted.

ARTICLE XI PREEMPTIVE RIGHTS

The Shareholders of the Corporation have a preemptive right to acquire proportional amounts of the Corporation's unissued and/or treasury shares upon the decision of the Board of Directors to issue and/or transfer additional shares.

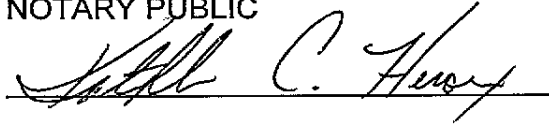
