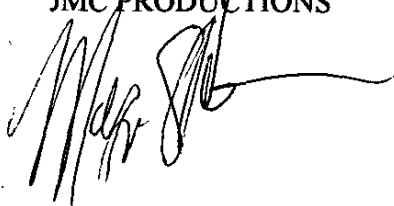
We were instructed by Mark at the FL Dept of State to attach this letter with the check for \$150, explaining our situation.
